Standing Orders

It will greatly help the Society if you can arrange to pay future subscriptions by standing order, as this reduces administrative and financial costs. You can do this either by sending a written instruction to your bank, or if you have internet banking, you can set up a standing order yourself. A form of written instruction is given below, which also includes the information you will need for internet banking.

Your first subscription is payable when you join, but thereafter subscriptions are due on 1 January each year. However, if you join on or after 1 September, your subscription will cover your membership for both the current and the following year and you will not need to pay again until January up to sixteen months later. You may need to allow for this when setting up a standing order.

In the written instruction below, the mandate is worded in such a way as to require your bank to make the initial payment immediately on receipt of the instruction, and then on each subsequent 1 January beginning in the year specified. Thus if you were to join in March 2016, your initial subscription would be paid then, and the next would be due on 1 January 2017. But if you joined in October 2016, the next payment would not be due until 1 January 2018.
